

TRAFFIC CODE

4.01 WEIGHT LIMITS ON TOWN ROADS

- (1) All streets, roads, and highways within the limits of the Town of Neenah are classified as Class "B" Highways pursuant to Chapter 349.15, Wis. Stats.
- (2) The Town Board or its designate may impose weight limits for any Town streets, roads, or highways at its discretion.
- (3) Any person violating the provisions above will be subject to forfeiture not less than \$200.00 and not more than \$500.00.

4.02 SPEED ZONES

- (1) Contingent upon the erection of proper signing, the maximum permissible speed at which vehicles may be operated on the various Town of Neenah streets is twenty-five (25) miles per hour, except as noted in **Chapter 4, Appendix I**.
- (2) Any person violating the provisions above will be subject to forfeiture not less than fifty dollars (\$50.00) and not more than \$200.00.

4.03 STOP SIGNS

- (1) Stop signs shall be erected at the intersections noted in **Chapter 4, Appendix II**.
- (2) Any person violating the provisions above will be subject to forfeiture not less than fifty dollars (\$50.00) and not more than \$200.00.

4.04 PARKING, STOPPING, AND STANDING

- (1) Contingent upon the erection of proper signing, no parking is permitted on the following Town of Neenah roads, except emergency parking:
 - (a) Any roadway within a Town of Neenah park in excess of the length of time or between the hours specified by the Board. See Subsection 15.02(9) herein.
 - (b) Any Town of Neenah road from December 1 to April 1 from 2:00 a.m. to 7:00 a.m.
 - (c) Green Valley Road between the south driveway of Greenlawn Memorial Cemetery and the town line on the west side of the road.
 - (d) Larsen Road between Oakridge Road and Clayton Avenue on either side of the road.
 - (e) Maple Lane between Bayview Road and Hunters Point Road on the south side of the road.

- (f) Nee-Vin Road between Green Valley Road and a point 400 feet west of Green Valley Road on the north side of the road.
 - (g) South Park Avenue between South Commercial Street and Bell Street/Maple Lane on either side of the road.
 - (h) Tullar Road between Winneconne Avenue and Oakridge Road on either side of the road.
- (2) Any person violating the provisions above will be subject to forfeiture not less than twenty dollars (\$20.00) and not more than \$200.00, except that any person who violates Subsection (1)(b) shall be subject to forfeiture not less than \$100.00 and not more than \$500.00, and any vehicle parked in violation of Subsection (1)(b) shall be towed at the owner's expense. Each day or part thereof that a violation of this Section occurs shall be deemed a separate violation.

CHAPTER 4 - APPENDIX I

4.02 SPEED ZONES

- (a) State, Federal and County highways (limits set by other jurisdictions).
- (b) Ten (10) miles per hour:

Anywhere within a Town of Neenah park. See Subsection 15.02(4) herein.
- (c) Twenty (20) miles per hour:

Marked school zone: Green Bay Road between the northern approach to Plummer Court and the northern approach to Geiger Street.
- (d) Thirty (30) miles per hour:
 - 1. Meadow Lane between Winneconne Avenue [Highway 114] [JJ] and Cecil Street.
 - 2. Radcliff Road.
 - 3. Sunrise Bay Road.
 - 4. Villa Drive.
- (e) Thirty-five (35) miles per hour:
 - 1. Breezewood Lane between Tullar Road and a point 0.5 miles west of Tullar Road.
 - 2. Deerwood Drive between STH 150 and a point 150 feet north of Glenview Drive.
 - 3. Dell Court.
 - 4. Green Bay Road between Winneconne Avenue and North Street.
 - 5. Maple Lane.
 - 6. Oakridge Road between the eastern town line and Harvard Drive.
 - 7. Pendleton Road between County Trunk Highway "S" and a point 0.15 miles south of County Trunk Highway "S".
 - 8. South Park Drive between Poplar Court and the town line.

(f) Forty (40) miles per hour:

Woodenshoe Road between STH 114 and Breezewood Lane.

(g) Forty-five (45) miles per hour:

1. Breezewood Lane between Wooden Shoe Road and a point 0.5 miles west of Tullar Road.
2. Clayton Avenue.
3. Dixie Road between County Road G and the southern town line.
4. Larsen Road between Clayton Avenue and a point 0.17 miles northwest of Oakridge Road.
5. Muttart Road between CTH "A" [South Commercial Street] and Dixie Road [East Frontage Road].
6. Oakridge Road between Harvard Drive and the western town line.
7. Pendleton Road [CB] between Oakridge Road and Winneconne Avenue [114] [JJ].
8. Tullar Road between Oakridge Road and a point 0.52 miles south of Oakridge Road.
9. Woodenshoe Road between Breezewood Lane and the southern townline

CHAPTER 4 - APPENDIX II

4.03 STOP SIGNS

- (1) Stop signs shall be erected at the following intersections:
- a. Adella Beach at South Park
 - b. Armstrong Street where it exits onto Breezewood Lane.
 - c. Bayview Road where it intersects with Rainbow Beach Road/Maple Lane going both directions.
 - d. Briar Drive where it exits onto Cumings Lane.
 - e. Carey Court where it exits onto Muttart Road.
 - f. Cheryl Ann Drive where it exits onto Breezewood Lane.
 - g. Cooke Road where it exits onto Deerwood Drive.
 - h. Glenview Drive where it exits onto Deerwood Drive.
 - i. Hidden Acres Lane where it exits onto Maple Lane.
 - j. Jonathan Street where it exits onto Maple Lane.
 - k. Kappell Avenue where it exits onto Lyndale Avenue [G].
 - l. Kuettel Court where it exits onto South Park Avenue.
 - m. Mahler Park exit road where it exits onto South Park Avenue.
 - n. Mandella Court where it exits onto Muttart Road.
 - o. Maple Lane where it exits onto South Park Avenue.
 - p. Maple Lane where it intersects with Bayview Road.
 - q. Old Orchard Lane where it exits onto Bayview Road.
 - r. Plummers Harbor Road where it exits onto Maple Lane.
 - s. Poplar Court where it exits onto South Park Avenue.
 - t. Rainbow Beach Road where it intersects with Bayview Road.
 - u. Ridgeway Drive where it exits onto Deerwood Drive.
 - v. Schramm Way where it exits onto Muttart Road.
 - w. Shreve Lane where it exits onto Deerwood Drive.
 - x. Silverwood Lane where it exits onto Deerwood Drive.
 - y. Strohmeyer Drive where it exits onto Deerwood Drive.
 - z. Sugar Tree Lane where it exits onto Muttart Road.
 - aa. Villa Drive where it exits onto Bayview Road.
 - bb. Villa Drive where it exits onto South Park Avenue.
 - cc. W. North Plummer Court [Rockledge Lane] where it exits onto Tullar Road.
 - dd. Woodenshoe Road where it intersects with Breezewood Lane going north.
 - ee. Woodside Acres where it exist onto Woodenshoe Road.
